Notification of Termination of the Online Game Investment Project

Our company announced the launch of our online game investment project on February 2, 2002. The current notice is to announce the termination of this project.

1. Reason for the Termination

Until the present time, our company has financed an online game investment project (hereinafter referred to as “the project”) through a subsidiary company. In addition to providing capital to an online game company, which demonstrated excellent growth potential, we realized a synergistic affect, and an opportunity to generate significant revenues in the ever-expanding online game market. However, due to legal changes in recent years, it has now become problematic to maintain the investment format of the project, and so we have decided to terminate it. This decision will enable us to more effectively use our business resources and to boost corporate value for our entire group.
